<b>Completion/Graduation Rate (Including Disaggregated Completion/Graduation Rates)</b>	Pursuant to the federal Student Right-to-Know Act, on an annual basis, the College determines and makes available an overall graduation rate of diploma or degree-seeking, first-time, full-time students.
