

## Funding Report for Quarter Ending on 09/30/2020

## Higher Education Emergency Relief Fund Report – Emergency Financial Aid Grants to Students

**Community Based Education & Development, Inc. (OPE ID: 032503-00)** received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"), Public Law No: 116-136. This Fund Report applies to the student portion received under the Higher Education Emergency Relief Fund that is designated exclusively for emergency financial aid grants to students.

The institution appreciates that Congress and the President have made these critical funds available for eligible students who have expenses related to the disruption of campus operations due to the coronavirus pandemic. We take receipt of these federal funds seriously and are distributing them in accordance with the CARES Act and implementing guidance. The institution is making the below information available for transparency purposes and in compliance with the U.S. Department of Education's ("Department") Federal Register Notice, published on August 28, 2020 revising the Department's original May 6, 2020 Electronic Announcement.<sup>1</sup> For questions or concerns regarding this Fund Report, please contact **Anna Panosyan**, **Director**, **Financial Aid**, at <u>caresact@cbd.edu</u>.

- 1. The institution signed and returned to the Department the Certification and Agreement [for] Emergency Financial Aid Grants to Students. The institution has used no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide emergency financial aid grants to students.
- 2. The total amount of funds that the institution has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$479,658.
- 3. The total amount of emergency financial aid grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is \$479,658.
- 4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, and thus eligible to receive emergency financial aid grants under Section 18004(a)(1) of the CARES Act is **788**.
- 5. The total number of students who have received an emergency financial aid grant under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is **545**.
- 6. The methods used by the institution to determine which students receive emergency financial aid grants and how much they would receive under Section 18004(a)(1) of the CARES Act are provided at **Attachment A** below.
- 7. Any instructions, directions, or guidance provided by the institution to students concerning the emergency financial aid grants are provided in **Attachment B below**.

### Attachment A

The information below represents student eligibility requirements and award calculation methodology used for the disbursement of funds received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students. The institution first distributed the application for Emergency Financial Aid Grants to Students on May 8, 2020 and subsequently distributed the grants to eligible students. Students who did not apply for a grant through the initial disbursement of funds, were are able to apply to receive funds from the <u>remainder</u> of the allocation for Emergency Financial Aid Grants to Students. CBD College distributed the application for Emergency Financial Aid Grants to Students on August 17, 2020. In accordance with guidance issued by the Department of Education on June 16, 2020 titled Supplemental Frequently Asked Questions under Section 18004 of the CARES Act (subsequently revised) CBD College distributed the remainder of its student allocation using the same distribution formula as the initial distribution.

CBD College requires that students submit an application to determine eligibility for CARES Act/HEERF grant. Not all who apply may receive a grant.

CBD College understands that students have been differently impacted by the disruption of campus operations due to coronavirus. The institution has established a maximum funding threshold for eligible students to ensure that these funds are distributed as widely as possible. In order to prioritize the limited funds that are available and proportionally allocate more to those who have incurred more expenses, CBD College has created a tiered grant amount program. The grant amount that each eligible student receives is calculated based on a scoring methodology that accounts for demonstrated financial need/incurred expenses related to the disruption of campus operations due to coronavirus, as represented by answers on the grant application (on the four expenses-related questions), and on demonstrated financial need (Estimated Family Contribution) as reported on FAFSA submissions, as applicable.


